



## NDA (Non-Disclosure Agreement) and Terms for

### Wordsmith Star (henceforth called **WS**) & Wordsmith Star Awarding Ambassador (**WSAA**)

By signing this NDA and Terms, I understand, agree and promise to abide by the following as below

1. I shall visit the Awardee's premise and handover the award to them as briefed by Wordsmith Star.
2. WSAA should refuse all offers of hospitality / food without exception citing the "on duty" clause. All WSAA are officers on duty during awarding and it is 100% prohibited to accept any hospitality / food / discount whatsoever at the awardee's premise. This is to protect our clause of Incorruptibility. WSAA may politely refuse such cultural tradition and cite the on-duty and incorruptibility clause as we operate across various cultures.
3. WS will send me a fixed sum in advance covering the journey from my home to the premise of the awardees through Uber / private transport and the cost for dinner of 2 (WSAA and spouse) in a decent restaurant in the city. They need not send us any break-up and is considered a lump sum amount. This excludes the awarded restaurants and a cooling period of 3 months applies. After 3 months from the date of awarding, WSAA can visit the restaurant as a guest.
4. WSAA will take photos and other documentation as advised by WS during awarding. WSAA can take with him / any companion he may choose to take and allow permission to WS to publish this in their media including that of the companion.
5. **WSAA will not publish any such documentation in public before the documentation (pictures and videos of awarding) published officially by Wordsmith Star. After that, WSAA can publish as they wish, including in their personal social media.**
6. WSAA grants consent to WS to announce them as WSAA in public prior to awarding.
7. WSAA cannot demand any privilege, discount at any awardees place anytime citing his / her association with Wordsmith Star. See "Wordsmith Star Certificate of Non-Obligation."
8. WSAA cannot nominate someone else to handover as per his/her behalf. He/she can take other people but the awarding will be considered to be his own contractual task.
9. WSAA must complete the visit and submit the documentation within the deadline stipulated by WS / mutually agreed to.
10. WSAA is a freelance mode of work and in no way means any permanent / temporary employment in any shape or form.
11. All tax / levies etc for the funds received will be the responsibility of the WSAA.
12. WSAA are selected and assigned based on various factors and WSAA cannot demand any specific eatery / location
